Sealed Tenders are invited for making onam float for Kerala State Bharat Scouts & Guides at Thiruvananthapuram as per the terms and conditions detailed below;

- The work includes Making of Float as per Design, Fabrication, Art Work, Electrical Work, Lighting, Audio System, Generator, Carrying vehicle Rent, Labour etc. The tender should be addressed to the officer mentioned above in the sealed cover with the sample papers. The Tender number and name of work should be mentioned on the sealed cover
- 2. The tender should be in the prescribed form which can be obtained from the State Headquarters of Kerala State Bharat Scouts & Guides on payment of the price which is also noted above. The cost of tender form paid will not be refunded. Tenders which are not in the prescribed form are liable to rejected. The rates should be only in Indian currency.
- 3. The sealed tender should be reached the State Headquarters of Kerala State Bharat Scouts & Guides on or before due date and time as noted above. No tenders received after the specified date and time will be accepted on any reason.
- 4. The rates quoted will be considered firm for acceptance till the period mentioned in the tender schedule.
