Sealed Tenders are invited for the Printing of Token Flags for Kerala State Bharat Scouts & Guides at Thiruvananthapuram as per the terms and conditions detailed below;

- 1. The work includes printing of Scout Guide Token Flags for the year 2024 subject to approval of proof and print order by the State Secretary of KSBSG. Sample of paper should be approved by the State Secretary. Flags should be delivered to the office within 10 days of placing the print order. The said flags should be delivered to the state office only after cutting them in A4 size and bundling them according to the number provided by the State Headquarters. The tender should be addressed to the officer mentioned above in the sealed cover with the sample papers. The Tender number and name of work should be mentioned on the sealed cover.
- 2. The tender should be in the prescribed form which can be obtained from the State Headquarters of Kerala State Bharat Scouts & Guides on payment of the price which is also noted above. The cost of tender form paid will not be refunded. Tenders which are not in the prescribed form are liable to rejected. The rates should be only in Indian currency.
- 3. The sealed tender should be reached the State Headquarters of Kerala State Bharat Scouts & Guides on or before due date and time as noted above. No tenders received after the specified date and time will be accepted on any reason.
- 4. The rates quoted will be considered firm for acceptance till the period mentioned in the tender schedule.
- 5. Every tenderer should remit the Tender Form fee and EMD as prescribed in the Tender Schedule.
- 6. The EMD should be remitted as mentioned above directly to the state HQ of Kerala State Bharat Scouts & Guides or by demand draft in favor of the State Secretary, Kerala State Bharat Scouts & Guides from State Bank of India. The earnest money of unsuccessful tenderers will be returned as soon as possible by RTGS after the tenders are settled; but that of successful tenderers will be adjusted towards the final payment.
- 7. Late tenders will not be accepted at any reason.
- 8. The tenders will be opened on the appointed day and time in the State Headquarters of Kerala State Bharat Scouts & Guides, in the presence of such those tenderers or their nominees who may be present at that time.

- 13. The rate quoted should be inclusive of all expenses like DTP, Designing, cost of the materials, printing, transportation, wages, duties &taxes, loading and unloading etc.
- 14. The amount to be quoted is to print one flag (Single piece of Flag) by the bidder.
- 15. The payment will be made only after the successful printing and supply of Token Flag.

- 16. No representation for the enhancement of the rates once accepted will be considered at any circumstances.
- 17. In the cases of any disputes arises in connection with the contract, agreement, all illegal proceedings related to the proceedings relating to the matter shall be instituted in any Court in Kerala.
